#### **Minister's Report**

### "Time flies over us but leaves its shadow behind." Nathaniel Hawthorne

So, we're now living in the shadow of 2024. At Trinity it became a time of adjustment. Over the summer and into the fall, we welcomed Learning Cubs, our new tenant. As they entered, we gave up the use of the basement of our building – except for the kitchen. That meant making more use of the Sanctuary as a flexible space. That, of course, was partly our intent when we replaced the pews with chairs. We also reconfigured the Choir Room and added a kitchenette.

Elsewhere, within the life of the congregation, we also adjusted our worship services by making the gathering time a little more sacred. It was a reminder that we come to worship to be gathered into God's presence.

We also updated our website after years of saying that it needed to be refreshed. It is another necessary tool in telling Trinity's story. In the 21<sup>st</sup> century that we live in, that is where most people turn when they want to know more about us.

Trinity also continues to be an active player in the South Simcoe Cluster of United Churches – or simply *The Cluster* as we've become comfortable calling it. The leadership gathers six or seven times a year and we've hosted a Chili Lunch, Fall Worship & Picnic, Sing, Sing, Sing and other events that create a stronger community and connection among our congregations.

A few months ago, the leadership of the Cluster gathered to watch a webinar presented by a Stewardship staff member of our denomination. Having attended many church seminars, workshops, symposiums, and the like over the years, I sometimes go into these events a little skeptical.


Too often they're geared to other settings – more urban, multi-staff, ... etc. Now, I've been in ministry long enough to know how to translate ideas and concepts into my own context – or at least know how to ignore things. But I came away from this particular webinar with some good stuff.

One thing that was presented to us was the *Discipleship Flower – Key Spiritual Practices*. It names the key areas of a congregation's life. They are *Prayer, Loving Service, Worship, Bible Study, Sharing Faith and Generosity*. They allow a congregation to balance who they are and want to become. They allow us to be more informed stewards of our faith.

Over the last few months, I've been looking at this tool and making notes on what Trinity does within those areas and how we might strengthen ourselves. I believe it can help us understand more fully that Stewardship is more than fundraising – it lives with all aspects of our congregational life.

So, take a look at our 2024 Annual Report. Read the stories of our Spiritual Practices – even if it means putting in cupboards. People offered to do it, our gifts made it possible and our community of faith was able to continue to offer hospitality and gather around a cup of coffee or tea.

#### Session

Trinity continues to grow through its community outreach programs. Monthly "Games Night" and "Learn & Lunch program" have been enjoyed throughout the year and participants look forward to each event. Three concerts were held this year that saw new people visiting our church. They enjoyed Naomi Bristow in May, The Skyliners Big Band in September and Good Company in November.

Making ourselves known outside the building has helped. In 2024, the electronic sign was utilized fully to let passersby know what is happening. This attracted people into our events like the Chili lunch. The website was also refreshed and updated in 2024 and has now become a source of information for many.

The Poppy Project in conjunction with St.Andrew's Presbyterian church created a display of knit or crocheted poppies that welcomed the veterans at the November Remembrance Sunday Service. Many hands contributed to this project – some people crafted the poppies, some sewed them to the mesh, while others helped to hang the banners. Others admired the display and commented on it. A truly community project.

Our Sunday morning worship services anchor us each week so we are able to carry out our mission of spreading love and understanding to the world outside our doors. We have seen some new faces join us on Sunday mornings and have seen friendships bloom.

We have enjoyed several guest speakers this year. From the South Simcoe Cluster training for Lay Worship Leaders, we met and heard from Cherly LeLiever in April, Jayne Asselstine in September and myself, Sue Zylski, in January and June. We were also able to welcome back Patricia (Pat) James in September as she is now retired and able to do pulpit replacement.

From our association with the other South Simcoe United Churches in our "Cluster", we were able to host a Chili lunch in February and "Sing, Sing, Sing" event in October. Some of us also participated in a workshop on Pastoral Care.

There is always so much going on at Trinity and we are grateful for all the services and events that so many enjoy.

#### Stewards

The Stewards of Trinity United Church have once again been hard at work as we close out another year. We began the year by securing contractors to rough in plumbing and electrical work for the new kitchen in the choir room. The Stewards then took on the task of installing cabinets, countertops, a sink, taps, and a refrigerator to complete the project. Following this, we focused on renovating the basement washrooms, which included relocating copper piping for the backflow valve and restoring proper flushing mechanisms.

Our next major project involved securing an agreement with Learning Cubs Childcare, which now operates in the church basement. Finalizing the contract required several mandatory renovations to ensure the daycare facility's success. These renovations included installing fire-rated doors, correcting the emergency lighting system, installing 40 feet of missing fencing in the backyard, preparing a fire plan, and installing keyed locks throughout the church, among other tasks. While coordinating with daycare operators, fire marshals, and various Ontario ministries proved challenging at times, our efforts resulted in the successful opening of Learning Cubs Childcare. With the daycare now operational, we can take pride in knowing that our church is providing a valuable service to the community.

In addition to these larger projects, the Stewards diligently handle the church's daily operations. Tasks include repairing grass-cutting equipment and finding volunteers to maintain the lawn, shoveling snow around entrances, repairing the driveway, removing dead tree limbs, fixing emergency push bars, and plastering and painting areas in need of care. We also ensure the church's annual maintenance requirements are met, such as keeping the lift operational, maintaining furnaces, plowing the parking lot, and addressing other essential upkeep to keep the church in excellent condition.

The Stewards are also integral to the success of the church's many fundraising events. Whether setting up for the plant, book, and bake sale, preparing chairs and audio equipment for concerts, or ensuring the sanctuary looks its best throughout the year, Stewards are always ready to lend a hand.

We take pride in the work we do and remain committed to diligence and excellence. Our goal is to make Trinity United Church a beacon of light and service within our community.
